

Klavzula o izključitvi odgovornosti za predstavnike medijev

1. člen

Zavedam se tveganja in nevarnosti pri tovrstnih motoriziranih športnih prireditvah in se s svojim podpisom zavežujem, da bom takoj in brezpogojno upošteval navodila organizatorjev, rediteljev, policije in drugim predstavnikov, in pa tudi njihove ukaze (pisno, ustno ali vizualno). To velja še posebej za prepoved vstopa v katerokoli prepovedano območje.

2. člen

Izjavljam, da v primeru, če zapustim območje, ki je namenjeno obiskovalcem, ravnam na lastno odgovornost, tudi če so mi to odobrili organizatorji.

3. člen

Odstopam od pravice, da bi jaz ali kateri koli izmed mojih pravnih naslednikov za telesne poškodbe, materialno škodo ali ekonomsko izgubo, v kolikor se nahajam zunaj površin, ki so namenjene obiskovalcem in gledalcem (glej 2. člen) in je prišlo do nesreče ali škode, ki je bila nenamerno povzročena s strani katere izmed spodaj naštetih oseb, klical na odgovornost:

- FIA, FISA, CIK, ONS, njihove predsednike, člane, pooblaščenice, plačane ali neplačane zaposlene
 - Organizatorje, njihove predstavnike, uradne osebe in strokovne sodelavce
 - Lastnike dirkališča in njegove predstavnike
 - Voznike, sovoznike, registrirane imetnike vozila, tekmovalce in njihove asistente
- Oblasti, uradne osebe pri tekmovanju ali druge osebe, ki so kakor koli povezane z organizacijo prireditve

4. člen

Zavedam se, da kršenje 1. člena vodi v odvzem tako novinarske kot tudi fotografske akreditacije.

5. člen

Digitalni ali analogni video posnetki so dovoljeni samo za zasebno rabo. Kakršna koli reprodukcija in distribucija v komercialne namene mora biti odobrena in potrjena s strani organizatorjev. Zloraba bo imela pravne posledice.

Non-liability Clause for Media Representatives

1. article

I am aware of the risks and dangers inherent in motor sports events and hereby obligate myself to immediately and unconditionally obey the directives issued by the organisers, the stewards, the police, the officials and their representatives, as well as their orders (in writing, oral and visually) which especially entails not entering any restricted areas..

2. article

I hereby state that I act at my own risk when I leave the area reserved for and publicly accessible to spectators even if my staying outside above mentioned areas may be tolerated by the organisers.

3. article

I hereby resign the right for me and any of my dependants to hold liable

- the FIA, FISA, CIK, ONS GmbH, their chairmen, members, executives, salaried and unsalaried employees
 - the organisers, their representatives, officials and assistants
 - the owners of the racing course and their representatives
- the drivers, co-drivers, registered keepers, vehicle owners, competitors and their assistants, as far as it concerns a race, a special stage designed to reach high speed or the shortest possible driving time or a reconnaissance to this behalf
 - authorities, racing officials and other persons connected with the organisation of the event
 - for bodily harm, material damage and economic loss as far as I am staying outside the areas reserved for and publicly accessible to spectators (see 2. article) and an accident or damage has been neither with intent nor wantonly negligently caused by the above Mentioned group of persons

4. article

I am aware that a violation of 1. article will lead to the revocation of the press accreditation, respectively the photographer accreditation.

5. article

Digital or analogue video recordings are only permitted for private use. Any commercial reproduction and distribution of digital or analogue video recordings must be agreed upon and authorized in writing by the organisers, A failure to comply will be exclusively prosecuted by legal action.
